



HOW TO VOTE IN NEW YORK

A Quick Guide for People with Disabilities Voting in the 2022 General Election on or Before November 8, 2022.



REGISTERING TO VOTE

- **How can I register to vote?** You can register:
 - If you have already registered, you can check if you are registered to vote at vote411.org.
 - Online at New York's [Online Voter Registration Website](#).
 - By downloading and mailing the New York [mail in registration form](#).
- **When do I need to register?** Be sure to register to vote on or before October 14, 2022. New York does not allow people to register after this date or on Election Day for this election.
- **Do I need identification (ID) to register?** You will need to have a New York address and New York state ID card or driver's license. You can use your social security number if you don't have a state ID.
- **Can I vote if I have a disability?** Yes! People with disabilities who are 18 years old or older have the right to vote. Your vote matters and is protected by laws to make sure voting is accessible, independent, and private. If you have a guardian, you can still vote, unless a judge said you cannot vote. - **Can I vote if I have gone to jail or prison?** If you have gone to jail or prison, you should check to see if you are allowed to vote. Learn about voting rights for people who have [gone to jail or prison](#). You can also [contact your local P&A](#).



LEARNING ABOUT THE ISSUES

- **What is a ballot?** A ballot is a list of who and what you can vote for. Your ballot will list candidates who are running for different offices, such as Senator or Representative. You vote by marking your choice on the ballot.
- **What is a ballot measure?** Sometimes, your ballot will have ballot measures. A ballot measure is a law, issue, or question that you can vote on. Voters get to decide if they agree or disagree with the ballot measure by voting yes to agree or no to disagree. You can learn about ballot measures on the New York [election website](#).
- **Can I look at my ballot before I go to vote?** Enter your home address in [Ballotpedia's Sample Ballot Lookup](#). This tool will give you a "sample ballot," which will show you what will be on your ballot when you vote.



VOTING IN PERSON

- **Where do I need to go to vote?** The place where you go to vote in person is called a poll site. You can find your local poll site through the New York election website. [Find your poll site](#).
- **Can I vote before Election Day?** New York allows any voter to vote in person before Election Day during the Early Voting period. You can vote between October 29, 2022 and November 6, 2022 and avoid lines on Election Day!
- **Can I vote outside if the poll site is inaccessible?** No, New York does not allow voters to vote outside the poll site if it is inaccessible.

- **What if I want help with filling out my ballot?** You may choose someone to help you vote. Your helper cannot be a candidate or your boss. If you are part of a labor union at work, the person who helps you vote cannot be a representative of that labor union. [What is a labor union?](#) You may also ask for help from poll workers at the poll site.
- **Do I need an ID?** New York does not require voters to show ID when voting in person, unless it is their first time voting in a federal election in New York. [Learn about voter ID.](#)



VOTING BY MAIL

- **Can I vote by mail?** If you have a disability or you are away from home on Election Day, you may vote by mail in New York. This is called absentee voting. [What is absentee voting?](#)
- **How do I request a mail ballot?** You must request your absentee ballot online or in person through your county election officials. [Request your ballot.](#)
- **Can I get an electronic absentee ballot?** New York allows voters with who are blind or have low vision to request a PDF ballot that they can fill out electronically, print, and return. [Request electronic ballot.](#)
- **When do I need to request my ballot?** The last day to request an absentee ballot is October 24, 2022. Make sure to request your ballot as soon as possible so you can receive your ballot on time.
- **Do I need to sign my ballot?** Be sure to sign your ballot or envelope when asked, since New York requires this signature to match one of your past signatures. If you are unable to sign the ballot yourself, you can have someone sign your ballot as a witness.
- **What if I want help with filling out my ballot?** You should be allowed to choose someone to help you with filling out your ballot. You will need to have a witness sign a statement on the ballot envelope if you are unable to sign the envelope yourself.

- **How do I return my ballot?** You can return your ballot by mail, or in person, to the board of elections office, early voting site, or poll site. If you are returning your ballot by mail, it must be postmarked by November 8, 2022, and received by election officials on November 15, 2022. If you are returning your ballot in person, it must be received by 9 p.m. on November 8, 2022.
- **Can someone return my ballot for me?** Yes, you may choose to have someone return your ballot for you.
- **Do I need an ID to vote by mail?** No, you do not need an ID when voting an absentee ballot by mail unless you are voting for the first time in a federal election in New York.
- **Can I track my ballot?** Unfortunately, you cannot track your ballot online to see if the elections office has received it. You can help make sure your ballot counts by returning it as early as possible and following the instructions as best as you can.
