



HOW TO VOTE IN OKLAHOMA

A Quick Guide for People with Disabilities Voting in the 2022 General Election on or Before November 8, 2022.



REGISTERING TO VOTE

- **How can I register to vote?** You can register:
 - If you have already registered, you can check if you are registered to vote at vote411.org.
 - Online at Oklahoma's [Online Voter Registration Website](#).
 - By downloading and mailing the Oklahoma [mail in registration form](#).
- **When do I need to register?** Be sure to register to vote on or before October 14, 2022. Oklahoma does not allow people to register after this date or on Election Day for this election.
- **Do I need identification (ID) to register?** You will need to have a Oklahoma address and Oklahoma state ID card or driver's license. You can use your social security number if you don't have a state ID.
- **Can I vote if I have a disability?** Yes! People with disabilities who are 18 years old or older have the right to vote. Your vote matters and is protected by laws to make sure voting is accessible, independent, and private. In Oklahoma, if you have a guardian, you might not be allowed to vote. You should check your guardianship order to see if you are allowed to vote. For help understanding or getting back your right to vote, contact your local [Protection and Advocacy Agency \(P&A\)](#).

- **Can I vote if I have gone to jail or prison?** If you have gone to jail or prison, you should check to see if you are allowed to vote. Learn about voting rights for people who have [gone to jail or prison](#). You can also [contact your local P&A](#).



LEARNING ABOUT THE ISSUES

- **What is a ballot?** A ballot is a list of who and what you can vote for. Your ballot will list candidates who are running for different offices, such as Senator or Representative. You vote by marking your choice on the ballot.
- **What is a ballot measure?** Sometimes, your ballot will have ballot measures. A ballot measure is a law, issue, or question that you can vote on. Voters get to decide if they agree or disagree with the ballot measure by voting yes to agree or no to disagree. You can learn about ballot measures on the Oklahoma [election website](#).
- **Can I look at my ballot before I go to vote?** Enter your home address in [Ballotpedia's Sample Ballot Lookup](#). This tool will give you a "sample ballot," which will show you what will be on your ballot when you vote.



VOTING IN PERSON

- **Where do I need to go to vote?** The place where you go to vote in person is called a polling place. You can find your local polling place through the Oklahoma election website. [Find your polling place](#).
- **Can I vote before Election Day?** Any voter may vote early in person before Election Day during the Early Voting period. You may vote between November 2, 2022 and November 5, 2022 to avoid lines on Election Day!
- **Can I vote outside if the polling place is inaccessible?** Yes, Oklahoma does allow voters to vote outside the polling place if it is inaccessible. This is called curbside voting.

- **What if I want help with filling out my ballot?** You may choose someone to help you vote. Your helper cannot be a candidate or your boss. If you are part of a labor union at work, the person who helps you vote cannot be a representative of that labor union. [What is a labor union?](#) You may also ask for help from poll workers at the polling place.
- **Do I need an ID?** Oklahoma requires voters to either show photo ID or sign a statement, called an affidavit, to vote. [What is an affidavit?](#) [Learn about voter ID.](#)



VOTING BY MAIL

- **Can I vote by mail?** Any voter in Oklahoma can vote by mail. This is called absentee voting. [What is absentee voting?](#)
- **How do I request a mail ballot?** You must request your absentee ballot online, by mail, email, fax, or in person from your local election office. [Request your ballot.](#)
- **Can I get an electronic absentee ballot?** Oklahoma does not have an electronic absentee ballot available for voters with disabilities, so you must vote on a paper ballot.
- **When do I need to request my ballot?** The last day to request your ballot is October 24, 2022. Request your ballot as soon as possible to make sure that you receive your ballot on time.
- **Do I need to sign my ballot?** Be sure to sign your ballot envelope when asked, since Oklahoma may require this signature to match one of your past signatures. Voters who vote on a regular ballot must have their ballot witnessed by a notary. [What is a notary?](#)
- **What if I want help with filling out my ballot?** Voters who need help with marking their ballot must apply for a "Physically Incapacitated Ballot." You can have a helper help you fill out this ballot and then have two witnesses sign the ballot. The voter and the helper must also sign or mark the ballot. [Learn about Physically Incapacitated Ballots.](#)

- **How do I return my ballot?** You can return your ballot by mail or in person. If you are returning your ballot by mail, it must be received by election officials by 7 p.m. on November 8, 2022. If you are returning your ballot in person, it must be received by close of business on November 7, 2022.
- **Can someone return my ballot for me?** You may have your spouse return your ballot for you if you are married, or you must return the ballot yourself.
- **Do I need an ID to vote by mail?** No, you do not need an ID when voting an absentee ballot by mail unless you are voting for the first time in a federal election in Oklahoma.
- **Can I track my ballot?** Yes, you can track your ballot online to see if the elections office has received it. You can do this on the Oklahoma election website. [Track your ballot.](#)
